


<u>United in Crisis</u> is a global training organization dedicated to uniting and equipping churches to form local crisis response church networks that address the emotional, spiritual and physical needs of those affected by crisis. With more than 15 years of experience, and a combined total of 36 years in mobilizing and training church networks in crisis care, the nonprofit has developed the Crisis Response Church Network (CRCN) model.




As catastrophes increase in frequency and intensity, the role of churches in crisis response becomes even more critical. United in Crisis offers a pathway for churches to engage with their communities on a deeper level through the CRCN model. By first meeting the physical and emotional needs of those whom a disaster has impacted, CRCNs can share the light of Christ in times of great need. Through trained volunteers, organized networks and a heart for service, CRCNs will be positioned to significantly impact the nation.

The CRCN model consists of the following elements:

- Formation: A spiritual leader forming a CRCN in their community by creating a 501c3 nonprofit organization with its own board, bylaws, financial structure and leadership team.
- Building a church network: Churches within a local community joining a local CRCN.
- Training volunteers: Volunteers from the local churches join the Network and receive training emotionally, spiritually and physically to respond quickly when crisis strikes.
- Shepherding families: Trained volunteers walking alongside survivors, providing emotional, spiritual, and physical support until they are back on their feet in a safe and clean home.

The vision of United in Crisis is to see every church in every city united and ready for crisis so His way may be known on the earth and His salvation to the nations.






Daniel GeraciFounder and CEO, United in Crisis

Daniel Geraci is the Founder and CEO of United in Crisis, a training organization focused on uniting and equipping churches around the globe to form local crisis response church networks that meet the emotional, spiritual and physical needs of survivors.

Previously, as the Founder and Executive Director of the Austin Disaster Relief Network for fourteen years, Daniel led the effort to assist hundreds of thousands of disaster survivors, train over 20,000 volunteers, raise more than \$22 million to help affected families, and help launch several church networks amid crises. He has provided assistance and training to churches and cities in Houston in the aftermath of Hurricane Harvey, in Moore, Okla., in the aftermath of an F5 tornado and the Texas Hill Country floods in 2018, to name a few. In total, he helped to launch a church network in nine cities during times of crisis.

Geraci released his debut book, <u>United in Crisis: A True Story of God's Miraculous Power Working Through a United Network of Churches</u>, in May 2024. He lives in Odessa, Missouri with his wife Allison and two daughters. He enjoys spending time with family, hiking, hunting and camping.




